Raw Materials Company Inc. currently operates a battery recycling plant in Port Colborne, Ontario, with warehouses in Port Colborne, ON and Buffalo, NY, providing industrial waste services. Raw Materials Company Inc. is committed to the health, safety and welfare of our employees and all people affected by our operations.

Raw Materials Company Inc. is committed to the prevention of all injury and ill health and to the continual improvement of our Occupational Health and Safety (OH&S) management and performance. Raw Materials Company Inc. will work diligently to pursue best practices in Occupational Health and Safety and at all times strives to comply with applicable health, safety Legislation and Regulations in order to achieve our goal of zero illnesses and fatalities, and reduce injuries per employee.

Raw Materials Company Inc. shall review on an annual basis all of its OH&S programs for their effectiveness and legislative compliance.

Raw Materials Company Inc. utilizes an Internal Responsibility System (IRS), which defines everyone's responsibility in the workplace; both employees and employers are responsible for safety and for the safety of co-workers.

Joint Health and Safety Committee meetings will be held regularly to open communication between workers and management. This will allow for consultation and co-operation between the different levels of the company. Meetings will review inspections, incidents, on-going business, and assign responsibility to the solutions agreed upon.
